

## **Painting & Loan Update**

Originally, the Board had decided (once the colors of the buildings were selected by the homeowners) that the buildings would be painted on a 5 year plan. One fifth of the buildings, those that were in worst condition, decided by the contractors and the Board, were to be painted each year. Due to the funds we had, we actually painted one-third of buildings. Homeowners liked the finished result so much that they approached the Board and asked if the association would consider obtaining a loan to speed up the painting process.

The Board has worked diligently to secure a loan to complete the painting project ahead of the original 5 year plan. We have been unable to secure a loan due to the wording of the Autumn Heights covenants, conditions & regulations (CC&Rs) and the new Federal guidelines and State rules. To obtain a loan the CC&Rs need to be amended to give the Board the authority to use our monthly dues to make loan payments. Until that is accomplished, the painting will follow the original plan to have the project completed over 5 years.

The Board will be starting the amendment process to ensure that if a loan is ever needed in the future, it will be possible to obtain.

The process of amending the CC&Rs is very time consuming and will require getting 67% of the homeowner's to agree with the changes. If you would like to work with the Board on this process, please contact any Board member.

#### **CC&R Rental Amendment Update**

The Board of Directors is still trying to obtain the required signatures for the rental restriction. If you have not turned in your form, you will be contacted and asked to return your vote. We need an affirmative response by 67% (94) of the owners in order to move forward. We currently have 38 owners that have not responded.

### **Clubhouse Committee Update**

If you haven't seen our recent "updates" to the clubhouse, stop by on Saturday August 13 from 9:00–11:00 am for the **Meet the Board** event to see the new colors in the main room and to check our our newest amenity......**Autumn Heights Community Fitness Room.** Thanks to the wonderful volunteers, Autumn Heights now has a fitness room, that can be used from 5:00 am – midnight daily. You can access the fitness room with your pool key from the door that is at the front of the Community Center (left of the main doors). The Board of Directors have approved the following rules for usage.

#### **Fitness Room Rules**

- \*Children 12 and under are not allowed in the Fitness Center\*
- \*Teens between 13 and 16 are allowed when accompanied by an adult\*
- \*Do not use the equipment when wet or wearing swim wear\*
- \*Turn off all the equipment, fans and lights when done\*
- \*During peak use time, please limit your exercise to 30 minutes per machine\*
- \*Wipe down machines after use with antibacterial spray provided\*
- \*No loud music\*
- \*Food and drinks is prohibited (excluding water for hydration) Water must be secured in bottles with caps\*
- \*Shower after exercising before using the pool or hot tub\*
- \*Report any damage or equipment issues to Z&R Property Management immediately\*
- \*The Fitness Room is for residents and their guests only. Guests must be accompanied by an Autumn Heights resident at all times\*

**Please note:** The pool hours are 9:00 am -10:00 pm. The fitness room hours are outside the pool/hot tub hours. Anyone entering the pool outside the approved hours will be asked to leave the area immediately. Thank you for your cooperation.
